### President Ex-Officio Debbie McMullin:

Debbie is temporarily serving as the Acting-Chair of the Golf Committee following the resignation of Chair Matt Kambic. The Committee is waiting for an important HOA2 Board decision on integration of Club Life into Golf Committee's advisory role to the Board. Debbie advised she does not want to serve permanently as Golf Committee Chair, but plans to return to her role as Vice-Chair when a new Chair is appointed by the HOA2 Board. At today's Golf Committee meeting Debbie obtained unanimous support for changing 2023 monthly meeting dates from 2nd Tuesday afternoon of each month (in direct conflict with MPWGA Board meetings) to the 2nd Monday morning of each month. This will allow more female golfers to participate in the Golf Committee in the future. Debbie will update the President Ex Officio job description to include Golf Committee liaison responsibility and will submit it to Brenda.
