#### **Treasurer Lori Stegink:**

<u>Membership Chair Connie Simonds</u> indicated there were no new member sign-ups since the last meeting. The current membership is 110.

#### **Sponsorship Chair Tracy McGeorge:**

- Sonora Investments is interested in additional promotional opportunities. They would like for us to share our membership e-mails for their newsletter distribution. The Board voted NO to sharing our e-mails.
- The Moore Advantage Team will sponsor the **2024 C**ancer tournament in addition to the 2024 Mars/Venus **tournament**. She gave them a "discount" for **an** additional sponsorship; so, they will be paying \$750.
- Ironwood Dermatology will continue its sponsorship.
- She suggested having a lower dollar amount sponsorship level option (as Kim and Gail did for the Member Guest tournament) to see if we can get more sponsors and money that way.

### Rules Chair Jenni Farquhar:

- The question from a member was whether we could play a provisional ball on hole #15 at the Preserve when it is known that the original ball was in the penalty area. The local rule was discussed and it was decided that the only time a provisional ball could be played was if there was doubt that the original ball was in the penalty area. The rules of golf do not allow for a provisional in this situation and the Board voted to comply with USGA rules.
- Jenni will consult with Matt and Mike about setting up a possible drop area for TP #15 hole.

#### **Weekly Events Chair Linda Schauer:**

- On occasions where there is a last-minute cancellation and the Golf Genius has not been updated, a score of O(zero)should be inputted for the cancelled person.
- The 2024 schedule is completed, but she will reconsider replacing the Field Shot format for 2024.
- She submitted the 2024 calendar to Matt and is waiting for a response.

### **Special Events Chair Kim Cox:**

- She met with Mariallyn Oczak and Kathy Fox to discuss the 2024 Cancer Tournament. At this meeting most of the team members were identified.
- The Golf Shop will charge \$29.00 for the 2024 Cancer Tournament, rather than the \$45.00 originally quoted.

# **Social Chair Susan Salmeri:** No report.

#### **President Ex-Officio Debbie McMullin:**

- Desert Reflection is behind schedule at MV due to a manpower issue.
- The average pace-of-play at TP is around 3:45 to 4:05. Cross-over scheduling is working.
- Troon will replace Invited as our Golf Management Company as of 7/1/23.
- As of 8/1/23, North Star will replace the existing HOA2 accounting system.
- \$32,000 GIF will be used to fund the purchase of MV tee markers, yardage markers, etc.
- There will be no reversing the 9s at MV.
