Treasurer Connie Maslowski

Budget results in deficit spending projection of \$5,960, similar to past couple of years. This is intentional in order to use up part of excess cash in account.

- The current ending balance is \$13,659.99.
- Assumes sponsorships will be the same need to secure Robson or replacement sponsor for member/guest
- All special event and most budgets the same in 2025 as 2024
- Catalina Cup and Kachina budgets same, dropped Ironwood and Robson challenge due to lack of participation the last several years
- Donations normalized to \$150
- Seminar budget set to zero due to lack of use the last several years

<u>Membership Chair Connie Simonds</u> announced thus far we have 22 on-line renewal memberships for 2025. A suggestion was made to have a raffle to encourage early sign-ups. The Board agreed this was a good idea. The deadline for on-line sign-up to qualify for the raffle will be 12/1/24.

Sponsorship Chair Tracy McGeorge indicated Dr. Watson is paid in full.

Handicap Chair Cathy Quesnell: No report.

Rules Chair Jenni Farquhar:

Some members are still having problems on where to drop their ball after their shot goes into a penalty area. Jenni will address that in the next newsletter as well as the rules for hitting a wrong ball. A question came up about Environmentally Sensitive Areas on the MountainView Course. Jenni will check with Mike Karpe and inform the membership.

<u>Weekly Events Chair Jane Megrdle</u> would like to discuss distribution of KP prizes. Jane will check with Mike to see if the awards can be transferred to credit books.

Special Events Chair Donna Yon: Donna, Susan Salmeri, and Andi Dresch will be organizing the 2025 Cancer Event to be held 2/18/25. It will be an afternoon tournament with dinner to follow. - Brenda confirmed the 2024 MPWGA Holiday gift recipients: The Director of Golf, the Head Golf Professional, the Director of Agronomy, and the Head of Food & Beverage. The amounts should be the same to all departments: \$100.00 each.
