TREASURER'S REPORT: Connie Maslowski said she has had some complaints regarding how the budget is printed, so she has changed a few items. The budget is still \$7800 in the good. Budget and Spending Reports will be available at the Kick-off Dinner.

There will be separate accounting for the Cancer Tournament, as it is just pass-through in the MPWGA account. It was suggested that the Cancer entry forms be modified to designate where the incoming money should be allocated, such as directly to the U of A, golf, or dinner. Donna Yon will re-work the entry forms.

WEEKLY EVENTS: Jane Megrdle will announce the Ace of the Year at the Kick-off Dinner and Linda Schauer will do the chip ins and birdies.

President's Cup and Club Championship dates were recently changed, possibly to accommodate the Cancer Tournament. These two tournaments used to be held between November and April while the snowbirds are here. Lori Stegnik did an analysis of snowbirds vs year-arounders and it makes more sense to hold these two important tournaments between January and May.

SPECIAL EVENTS: Donna Yon reported that there is very low sign up for the Cancer Tournament. She has reached out to all of the golf groups, Men, 9ers, HOA1, and Saddlebrooke Ranch.
